# **Policy-Driven Change. National Education Policy (2020)**

Some of the Major Problems currently faced by the higher education system in India includes:

- a) A severely fragmented higher educational ecosystem
- b) Less emphasis on the development of cognitive skills and learning outcomes



- c) A rigid separation of disciplines, with early specialization and streaming of students into narrow areas of study
- d) Limited access particularly in socio-economically disadvantaged areas, with few HEIs that teach in local languages
- e) Limited teacher and institutional autonomy
- f) Inadequate mechanisms for merit-based career management and progression of faculty and institutional leaders
- g) Lesser emphasis on research at most universities and colleges, and lack of competitive
- h) Peer- reviewed research funding across disciplines
- i) Suboptimal governance and leadership of HEIs
- j) An ineffective regulatory system and
- k) Large affiliating universities resulting in low standards of under graduate education.
