Students were assigned the following grades, based on the complete course assessments.



### ASSIGNMENTS AND RESULTS

Assignments were disseminated during the course using a combination of the Learning Management System (LMS) and class presentations. These assignments were designed by the course coordinators to test the students on their understanding of the topics discussed during the various modules. All assignments were based on the *practical aspects* of course.

#### 6.1 Methodology of evaluation:

Each assignment carried ten marks. In total, the three assignments were worth 30 marks. Marks from ALL THREE assignments were used to obtain a final percentage score.

Thus, if a student scored 28/30, then the final percentage was calculated as 93.33% (28/40 x100).

Only students who had scored a minimum of 40% and above are eligible for certificates (refer to Appendix B).

#### **6.2** Composition of assignments:

Students were expected to upload on to the LMS their answers to TWO (out of the three) assignments. Since the relevance of publications is far less at the undergraduate-level, assignments focused on testing research and analytical skills. They were given two weeks to submit (upload) their answer scripts, which were evaluated by the Research Facilitator. Meanwhile, the class presentation was graded by Ms. Joshi.

Out of the 30 students who registered for the course, only one passed this course. Thus, **this course** had a passing percentage of 3.33%. Apart from the one student who submitted assignments, none of the students submitted any assignments (listed in the table above as AI, A II, and A III).

The final result was computed with the average of the three assessments and appropriate grades were assigned to the student. While the scores (marks) for two assignments (out of the three) were awarded on Linways, the grades were only included in the certificates.

#### 6.4 Recommendations:

Based on observations from sections 5 and 6.3, this report submits the following recommendations:


- a. The active participation of only one student in this course cannot be glossed over. While the Course Coordinators chose to continue the course despite poor participation from the students, crucial lessons must be addressed. They are:
  - i. Dissemination of brochures: The brochure should be circulated *at least* two weeks prior to the start of the course.
  - ii. Scheduling of the course: Several other VACs, which were offered by other departments, were scheduled for the same time-slot.
- b. The performance of the lone successful student although satisfactory shows room for improvement. Exposure to journal articles and official databases will develop skills such as data-interpretation. Moreover, familiarity with these sources of knowledge will enhance students' understanding of new developments within the subject.






Were objectives of the course clear to you? 1 response






To what level did the course expose you to new knowledge and practices. 1 response




#### Please rate the relevance of the course.

1 response




Please rate the usefulness of the course.


#### Would you recommend this course to others?
