#### Introduction

Drug abuse is one of the major challenges across the world as it continues to be a significant threat to global health and social well-being. The way drugs are impacting the youths and hampering their potential highlights the urgent need to find a solution to the drug problem. The Program was hosted by Ms. Beneranda Shadap and Ms. Pynshngainlangki Suting, MSW students of the Department of Social Work-PG, St Edmund's College, Shillong.

# 2. Prohibition, Control, and Punishment:

(a)Detailed discussion on the measures and punishments for the manufacture and distribution of drugs (b)Insights into the preventive and punitive provisions under the Act.

# 3. The Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances Act, 1988:

(a)Overview of Act No. 46 of 1988. (b) Explanation of the roles and responsibilities of permittees under the Act. (c) Discussion on activities considered as financing, abetting, or conspiring in drug trafficking.

# 4. Statistical Data on Drug Abuse:

(a) Shocking statistics from 2019 indicating that 8 crore people are drug abusers, a number which has increased to 10 crores. (b) Data specific to Meghalaya showing 2.5 lakh drug abusers and 304 traffickers, 30 of whom are female, with most coming from broken families or single-parent households.

# 5. The "Say No to Drugs" Pledge:

(a) All attendees took a pledge to abstain from drugs and support efforts to combat drug abuse.

The presentation was followed by an interactive session, where attendees had the opportunity to engage directly with Advocate Sten, seeking clarifications and discussing further on the topics presented. Towards the

She stated that self-defense is an essential topic for the youths it also provides good opportunity and it can also be one of the basic life skills of an individual in day today age. #### **Technical session**

The technical session was hosted by the resource persons, they instructed them to do a few warm ups so as to enable more oxygen to reach the muscles and feel free. Several techniques and steps are show if-

- 1. Someone grabbed/ choked by the neck, (a) Raise one hand (b) turn to the other side (c) Hit with the elbow
- 2. Strangling against the wall- (a) Raise on hand (b) turn to the other side pushing the hand of the opponent to the side

- 3. When choked with the elbow across the neck- (a) Trapped the elbow (b) wrist and one leg of the opponent (c) turn over to the side
- 4. Being kidnapped and pushed to the car- (a) Turn towards the kidnapper/ opponent and grabbed by the hand (b) dropped to the ground
- 5. When choked from behind- (a) Step one feet to the side (b) Go one step back, hold the hips/waist (c) Lift the opponent's leg.
- 6.Posture of boxing- Steps- (a) Angle (b) Jab (c) Slight movement of the leg (d)Throw punch





#### **Conclusion**

In conclusion, there were 8 techniques which were demonstrated by the team whereby the students were able to follow and practice. This program has made the students aware on the different possibilities that a person might encounter in their daily life activities. It has benefited the audience as to how they would be able to tackle when they face such uncertainties.
