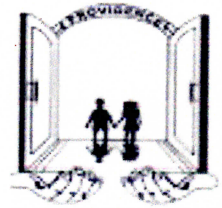

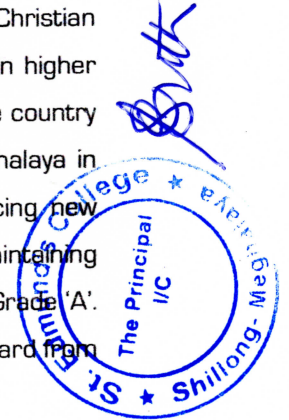

## MOU under Institutional Social Responsibility (ISR)

Providence School herein referred to as PS, represented by its Principal, Governing Body members & Managing Trustee, having its operating office at St. Edmund's Campus, Shillong, Meghalaya. (Hereafter called " PS " which term shall, wherever the context permits, mean and include its successors, representatives, administrators, and assigns) as one part

AND

St. Edmund's College, Shillong, Meghalaya, herein after referred to as SEC, located at Old Jowai Road, Laitumkhrah, Shillong, Meghalaya since its inception on 24<sup>th</sup> May 1923 by the Christian Brothers of India with its headquarters in New Delhi has been a Centre for excellence in higher education. SEC has been catering to the needs of the academia from various parts of the country and abroad. SEC is one of the premier institutions of the North East of India and Meghalaya in particular. Since its inception, SEC has maintained its excellence by regularly introducing new courses, updating its infrastructure, achieving the highest academic records, and maintaining discipline of the students. The college is affiliated to NEHU and accredited by NAAC with Grade 'A'. The college is also among the 26 colleges in India to receive prestigious STAR STATUS Award from the Department of Biotechnology, Government of India under its HRD programme.



Both institutions recognize the importance of **Institutional Social Responsibility (ISR)** in promoting inclusive education, community development, and empowerment of marginalized and differently abled individuals. In alignment with the principles of **NEP 2020**, the institutions agree to collaborate in programs that support education, skill development, and socio-economic empowerment. This Agreement shall be considered in effect upon the signatures of all representatives.

The terms and conditions of this MOU are as follows

### 1. Purpose

The purpose of this MoU is to establish a collaborative framework between PS and SEC to implement Institutional Social Responsibility initiatives, particularly for the empowerment of marginalized students and education of visually impaired and differently abled students.

The collaboration will focus on:

- Providing access to higher education
- Improving employability and livelihood opportunities through training and skill development.
- Promoting inclusive educational practices in line with NEP 2020 under Partnership for Learning Scheme.
- Facilitating community engagement and outreach programs through ZERO periods under Service Learning Scheme.

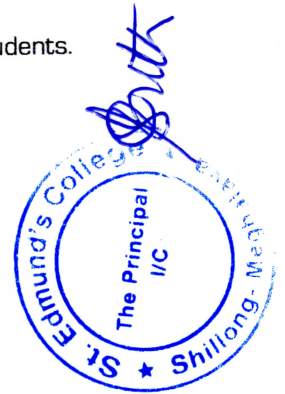
### 2. Roles and Responsibilities

#### Providence School (PS)

- Identify and recommend beneficiaries for ISR programs.
- Facilitate coordination with visually impaired and differently-abled students.
- Assist in implementing community-based programs.

#### St. Edmund's College (SEC)

- Provide training resources and academic support.
- Facilitate skill development and capacity-building programs.
- Provide access to institutional infrastructure where applicable.



Both institutions will jointly plan, implement, and review programs under this MoU.

### 3. Duration

The MOU comes into effect from 22<sup>nd</sup> April 2026 and shall be in vogue for a period of five years after it shall be suitably reviewed and renewed by the respective heads of the institutions involved.

### 4. Termination

Either of the parties are free to terminate the MOU in case they are not happy with the relationship or satisfied with the services provided by either of the agencies (service) and (partner) by giving one-month notice stating the reasons for termination which shall help either of the agencies to improve their relationship further.

### 5. Point of Communication

Both the parties shall nominate and appoint a designated person as nodal point of communication to ensure the smooth functioning. The nodal point of communication person shall appraise the head of the Institution or the head of the organization regarding the issues that arise from time to time. The issues or problems which may arise shall be resolved at the level of nodal point of communication, if necessary, beyond, which shall be referred to head the institution and finally to the head of the organization for resolving.
