I am to convey the decision of the 105th Academic Council vide Resolution No:AC:105:2020:5:7:(i) held on 10th December 2020 which resolved to grant renewal of Provisional Affiliation for Master of Social Work (MSW) (P.G.) with retrospective effect for a period of 3(three) years w.e.f. academic sessions 2019-20 to 2021-22 in continuation to the Affiliation granted vide this office letter of even No.2056 dated 9/1/2019.

The College is required to fulfill the following conditions as laid down by the Inspection Team:-

1. The Department has to procure the books on: Social Case Work, Social Group Work, Community Organisation, Social Welfare Administration, Social Work Research and Social Action and other books related to different specializations immediately. At least 20 books each to be procured from the Primary and Secondary Methods of Social Work.

2. The Department should procure the following Journal for the benefit of the students. The names are: Kurukshetra, Yojana, The Indian Journal of Social Work, Journal of Social Work

Education and Practice, and Journal of Rural Development.

3. The library needs to procure the latest edition of the Dewey Decimal Classification scheme to classify books, as the 19th edition that the library is using is outdated.

4. The Department requires two Field Work Coordinators immediately which is a mandatory requirement to coordinate the Concurrent Field Work, Rural Camp and Study Tours for the students.

5. The Department should immediately establish a field work laboratory to maintain the records

of all the field work activities of the students and teachers.

The Department may initiate establishing a Counselling Center to provide outreach services.

The fulfillment of the above conditions may be intimated to the undersigned at the earliest.
